

ST. GEORGE CITIZENS FILE THEIR OWN APPEAL

St. George electors and property owners appeal ruling denying the incorporation of the City of St. George

ST. GEORGE, La. (August 8, 2022) -

On October 12, 2019, the citizens of St. George voted in favor of incorporating the City of St. George. Since that time, Mayor-President Broome and Council Member Cole have fought against the citizens' right to vote by suing the incorporators.

For several years, St. George has been immersed in litigation. During this time, individual citizens were forced to remain silent. On August 8, 2022, individual citizens filed their own appeal in support of incorporating the City of St. George. Louisiana Revised Statute 33:5 authorizes individual electors and property owners within the area proposed for incorporation to appeal a judgment denying incorporation. The citizens of St. George will no longer be silent while the Plaintiffs, neither of whom reside in the incorporated area, continue to litigate to deny the incorporation and the citizens' right to vote.

On October 12, 2019, 17,422 (54%) voters in the area to be incorporated voted in favor of incorporation. The foundation of our country is the right to vote. This right to vote is sacred in America and elections have meaning. Now, the citizens of St. George raise their voice together demanding that the election to incorporate St. George be upheld.
